The lack of funds is due to the decrease in Sales Taxes experienced in the past 6 years (and GA DOE change in facility forward-funding). To compensate for the decrease in projected revenues, Social Circle City Schools has directed the Splost funds to Project 4-Acquring, constructing, and equipping an athletice complex.
- (5) Project 3 /SPLOST-WALTON was completed in June 2010 with total actual expenditures of \$1,646,556.46. The previous estimated cost was \$1,650,000. The surplus of SPLOST proceeds will be \$3,443.54 to go towards construction Project 4.
