I. Call Meeting to Order

Chairman John Callahan called the meeting to order at 6:30 PM with six members present: Ms. Lowana Bell, Mr. Randy Carithers, Mr. Rico Jackson, Mr. Michael O'Conor, Ms. Sabrina Sanford-Flint and Mr. Steve Trantham.

VI. Board Comment Section

Chairman Callahan welcomed everyone back to the new 2021-22 school year. He shared the opening football (scrimmage) game will be held Friday, August 13, 2021.

VII. Public Hearing - Tax Increase Hearing #3

For the third and final public tax increase hearing, Chairman Callahan shared the millage rate of 19.278 will remain the same for the upcoming year. There was no public discussion of the millage rate.

VIII. Break

Chairman Callahan called a very brief break for those who wished to leave.

IX. Finance

A. Monthly Financial Report

CFO, Mrs. Nicole Cross, explained there was no Financial Report to share due to the process of closing out Fiscal Year 2021. Once all July and August revenue and expenses are processed, the final ending financial report for FY21 will be available. This report should be available to share no later than October.

B. Freshway - Change for Schools

Mrs. Nicole Cross presented the Freshway-Change for Schools report. She explained the school does not receive any contributions during the summer months. (June contributions were sent to First Baptist Christian School - Social Circle.) Contributions to the school system will resume in August.

X. Superintendent's Report

A. Current Count

Dr. Hooker shared the current enrollment for each school:

- Primary School: 509
- Elementary School: 370
- Middle School: 480
- High School: 594

He further explained we will have more accurate enrollment information after the first ten days of schools once any withdrawals have taken place. Compared to last year, we currently have an increase of 104 students.

B. Safety and Technology Update - Todd Hilton

Todd Hilton, Director of Safety and Technology, provided to the board an update on Safety and Technology. The following highlights were included in his report:

- 80+ cameras installed in the Middle/High School,
- New cameras have been added to the athletic complex,
- 20+ cameras in the Primary and Elementary Schools,
- New cameras being installed on the playgrounds,
- Vape Detectors will soon be installed in the Middle/High School,
- Staff members all have Centegix badges that can be worn to call for assistance with the press of a button. These badges are able to alert local officials and can also be used to immediately lock down the school should there be an immediate need to do so,
- Lockdown drills are tested quarterly, fire drills are tested monthly, weather drills are ongoing,
- School Resource Officers (SRO) are located in all our school buildings,
- K-9 Unit makes periodic visits to our Middle/High School to assist administrators

Mr. Hilton shared that the Federal Emergency Management Agency (FEMA) is scheduled to perform a safety audit, in September, to provide feedback in areas that we may need to enhance.

As for technology, Mr. Hilton shared we currently have more than 2700 chromebooks thanks to the Facebook grant we received. The additional units are used to replace those that are damaged or misplaced. Additional grant money has been set aside for the purchase of new chromebooks next year.

The website was recently updated to provide much requested information directly on the homepage.

Further, Mr. Hilton shared information about the GoGuardian program installed on all of our chromebooks. GoGuardian is a tracking program that allows filters to avoid inappropriate use of our devices, a tracking system to track a device that may be lost or stolen and can identify those who may be speaking of or visiting sites that suggest self-harm or violence. An alert is sent to personnel who can immediately address each situation.

Upon completion of his update, Chairman Callahan asked if the busses are equipped with cameras and Mr. Hilton confirmed all busses do have cameras.

C. Superintendent Comments

Superintendent Dr. Hooker began by thanking the faith-based community for their support on the first day of school. Volunteers were on each campus and helped welcome the students back to school. Additionally, he thanked the faculty and staff for a great opening and welcoming the families, new and returning students, and attributed the successful start to both preplanning and the leadership at each campus.

D. COVID Update

To provide a COVID update, Dr. Hooker shared information from last school year and where we are currently in the 2021-22 school year.

- During the 2020-21 school year, 91 students tested positive (5%); 1036 students were quarantined (56%)
- Currently, 8 students have tested positive (.41%);
- Quarantines are optional for vaccinated/asymptomatic close contacts

XI. New Business / Action Items

A. For Review - Updating Board Policy GAE: Complaints and Grievances Superintendent Dr. Robbie Hooker shared the reason Board Policy GAE: Complaints and Grievances is being updated. Its amendment is to coincide with the recently approved Policy GBIA: Teacher Evaluation Appeals.

This policy amendment will sit for 30 days and board members will vote for approval in the September meeting.

B. Action Item - Millage Rate FY22 - Final Approval

Based on the Superintendent's recommendation, the board unanimously approved the millage rate of 19.278 mils for fiscal year 2022.
